The 22<sup>nd</sup> Annual General Meeting, of the Equestrian Federation of Assam was held on 06<sup>th</sup> of January, 2019, at 1700hrs at BCP conference hall, Dibrugarh, Assam.

01. Mr. Dilip Kr. Borah, IPS, Vice-President took the chair as the President Mr. Jayanto N. Choudhury, IPS, was not able to attend due to his official engagements.
02. Address by the Vice-President: Mr. Dilip Kr. Borah welcomed all to the Annual General Meeting and especially Mr. Lukas Karyanataufik Ibrachim, the FEI-nominated Trainee, who was in Dibrugarh for the Ninth Session of Retaining of Race Horses Coaching Camp conducted from 05<sup>th</sup> to 07<sup>th</sup> January, 2019 at Dibrugarh, Assam.
